



TERMS AND CONDITIONS

ANIMAYO 2026 INTERNATIONAL POSTER CONTEST

PRIZE MONEY: €500 FOR THE WINNER

CALL FOR ENTRIES

The production company *Damián Perea Producciones SL*, with registered office in Las Palmas de Gran Canaria, hereinafter referred to as “the Organizer,” announces the “ANIMAYO 2026 INTERNATIONAL POSTER CONTEST”, a competition that opens the doors to creativity and artistic promotion, with the aim of selecting the official poster for the 21st edition of the *Animayo Summit and International Film Festival*.

THEME

The theme of the poster should evoke the world of ideas and creativity, focusing on inspiration, fantasy, and/or technology.

DESIGN

The design must be created and submitted in two formats:

1. Vertical: 50 x 70 centimeters (width x height)
2. Horizontal: 100 x 50 centimeters (width x height)

Designs not adapted to both formats will not be accepted for the competition. See details in the section “Presentation Conditions and Formats.”

The poster design must include the following slogan as an integral part of the design:

- “Animayo 2026” (in larger font size)
- “21st Summit, Conferences and International Film Festival of Animation, Visual Effects and Video Games” (in smaller font size)

We recommend reviewing past winners and finalists on the Animayo website for reference.

SCOPE AND NATURE

- International.
- Free registration.

PARTICIPANTS AND ELIGIBILITY

- Minimum age: 16 years.
- Participants of any nationality and residence are eligible.
- Participants must have no personal, professional, or commercial affiliation, direct or indirect, with the Animayo Festival. Nor may they be linked to any of the companies sponsoring or collaborating with the Festival.
- Family members and employees up to the second degree of consanguinity or affinity of the organizing company, or any of its subsidiaries or affiliated companies involved in the activity and promotion of the contest, are excluded from participation.

CATEGORIES

- Single Category: Winning work.

The Animayo organization reserves the right to award Honorable Mentions (Accésit). These rules apply equally to both the winning work and any honorable mention, with specific conditions detailed later for each. The monetary prize for any honorable mention will be agreed upon by both parties.

REGISTRATION PERIOD

The registration period for the contest will be open from 9:00 AM on July 25, 2025, until 12:00 AM (midnight) on January 20, 2026, both dates inclusive (GMT +1).

ENTRY PROCEDURE

Registration must be completed through an online form governed by these rules, accessible at <http://www.animayo.com/>.

Works not previously registered through this form, with binding acceptance of these terms, will not be accepted:

- Participation may be individual or in groups.
- For group entries, the maximum number of participants is five. Only one group representative will be responsible for submitting the work. The prize will be awarded in their name.
- Once the registration form is completed, participants must submit their entries in both vertical and horizontal formats, with file sizes not exceeding 2 MB, by email to carteles@animayo.com. The email subject must read: "2026 Poster Contest," followed by the participant's name and the work's title.

- The submitted files do not need to meet the final poster's exact dimensions or quality but must maintain sufficient resolution to be clearly viewed and must not exceed 2 MB in size.
- The Animayo organization will contact the preselected participants before March 15, 2026, using the contact information provided in the registration form. Preselected participants will have 72 hours from notification to submit the final elements, fonts, and files at full size and 300 dpi for the jury's final evaluation.

- Digital images must be submitted in layered format.
- Vector-origin works must be submitted in an open editable format.
This is to ensure adaptability of the work to various formats, media, and applications necessary for the promotion and dissemination of the contest.
- The poster elements, fonts, and files must be sent by email to carteles@animayo.com, or via a cloud storage service with a shared link. The email subject must read: "Preselected 2026 Poster Contest," followed by the participant's name and the title of the work.

CONDITIONS AND PRESENTATION FORMATS

- The works must not display the name(s) of the author(s) visibly.
- Designs must be original, self-created, and unpublished.
- Posters must be submitted in digital format.
- Designs must be created in two formats: vertical (50 x 70 cm, width x height) and horizontal (100 x 50 cm, width x height). Additionally, all finalists will be asked to adapt their work to a size of 300 x 200 cm to verify suitability for the formats required by the Animayo Festival organization.
- Digital image designs must be submitted in layers. Vector-based works must be submitted in an editable (open) format.
- Any artistic technique is allowed. Drawings, photographs, 3D creations, or any original artwork are accepted. In the case of AI-inspired art, use of AI is limited to inspiration only, not full creation of the work. Submissions based on images created entirely or partially from textual prompts using AI will be disqualified. All submissions will be analyzed, and proof of full authorship may be requested to verify compliance with this rule.
- All designs must be accompanied by a brief description of the design, at least five lines of text, submitted via the same email.
- Original works will be retained until the contest is resolved to allow for possible joint exhibition of all selected works.
- No commercial trademarks may be referenced, and content must not be offensive in any form. The organization reserves the right to reject entries that, in its opinion, do not meet the technical, artistic, or legal conditions of the contest or that offend sensitivities, promote violence, discrimination, or contravene social norms.
- Participants are fully responsible for the absence of third-party rights in the works submitted, including image rights or similar claims.
- From the end of the contest period, the organization reserves the right to exploit the work, using it as the official festival poster and adapting the image to various promotional formats and graphic materials.
- Authors may not publicize their participation until the official list of selected and/or preselected works is published on www.animayo.com.
- Authors must provide reliable contact information for direct communication.
- Each participant or group may submit a maximum of five designs. No participant may receive more

than one prize in the same edition. Works must not have been awarded in any other contest.

FINALISTS

- The jury will be appointed by the Animayo Gran Canaria 2026 Steering Committee.
- From all submissions, the jury will select those deemed most suitable, assessing artistic quality and creativity.
- The jury will choose at least 15 preselected works, which, if compliant with the rules, will become finalists of the Animayo 2026 International Poster Contest.
- The finalists' list will be published on the website and/or social media before April 20, 2026.
- Finalist works agree to be exhibited on the Animayo website.
- Finalists' works may also be included in an exhibition held during the Festival.

JURY DECISION

- The jury will decide the winning poster from the finalists.
- The winner will be announced before April 20, 2026, on the Animayo website and/or social media at www.animayo.com.
- The jury's decision is final and unappealable.
- The jury may declare the prize void and resolve all matters not foreseen in these rules.

PRIZES

- Prize money for the winner: €500. The prize amount is subject to applicable taxes or withholdings according to the law, except in cases of exemption granted by the competent Tax Administration authority.
- Awarding of the prize is conditional on the winner's full compliance with these rules and the accuracy of data provided at registration. The prize is non-transferable.
- Commercialization of the prize or the right to receive it is prohibited.
- Waiving the prize grants no right to compensation or indemnity.

DATA PROTECTION, IMAGE RIGHTS, AND INTELLECTUAL PROPERTY

- In accordance with Organic Law 15/1999, of December 13, on the Protection of Personal Data, the personal data of participants in this contest will be incorporated into an automated file owned by Damián Perea Producciones S.L., headquartered in Las Palmas de Gran Canaria, with the purpose of managing participation in this contest. These data may also be used for acceptance, management, and delivery of prizes.
- Interested parties may exercise their rights of access, rectification, cancellation, and opposition at any time by written request to animayo@animayo.com, attaching a copy of their ID (DNI) or other valid identification document such as NIE or passport, indicating "DATA PROTECTION" in the subject line.

- Where participants have consented via the website, their personal data may also be used to send commercial communications, including electronic means, about products and services of Damián Perea Producciones S.L. and the companies belonging to its group.
- Contest participants commit not to plagiarize any artistic or advertising creation nor infringe on trademarks or any intellectual property rights of third parties. The Promoter shall be exempt from liability against any third-party claims. Participants will be responsible for any infringement caused or that may be caused to third-party rights with the submitted images and will indemnify the Promoter for any damages incurred due to non-compliance with the aforementioned obligation.
- By participating in this contest and accepting these rules, participants and their legal representatives automatically and definitively assign to Damián Perea Producciones S.L. all intellectual property rights of the winning work, as well as exploitation rights of the design subject to this contest. Specifically, exploitation rights including public communication, distribution, and reproduction are assigned. These rights may be used in any advertising format by the Promoter and across any communication media including television, Internet, analog and digital media, or any written media, without any remuneration, always crediting the authoring team.
- Likewise, winners of different categories and their tutors, parents, or legal representatives acknowledge and accept that images of participants may be taken and distributed by media reporters attending the official awards ceremony for publication in various media and formats.
- Furthermore, participants and their legal representatives consent to Damián Perea Producciones the right to use the design as the official image of the Animayo Festival and its itinerant events.

RESERVATION OF RIGHTS

- The Promoter reserves the right to disqualify participants who misuse the contest, commit fraud, or harm other participants. If the Promoter or any entity professionally linked to this contest detects anomalies or suspects that a participant is obstructing the normal process by illegally altering records through any technical or IT method, or committing fraudulent acts that undermine transparency, the Promoter reserves the right to automatically disqualify and withdraw prizes without explanation from all participants benefiting directly or indirectly from such fraudulent acts, and may take any civil or criminal legal action available.
- The Promoter declares that appropriate technological mechanisms have been implemented to detect any fraudulent, anomalous, or malicious activity that attempts to alter normal participation in this promotion.
- The Promoter reserves the right to take legal action against anyone committing acts considered manipulation or falsification of the promotion.
- The Promoter excludes any liability for damages of any kind resulting from temporary unavailability or interruption of the services through which participation is enabled, loss of expected utility by users, including but not limited to failures accessing participation pages via the Internet or telephone communications enabled for this purpose.

ACCEPTANCE OF TERMS

Participation in the contest implies full acceptance of these terms and express submission to the promoter's interpretive decisions. Winners may be required to sign a document accepting all terms and conditions of the contest. The period for claims ends 15 calendar days after the contest conclusion. These rules are deposited on the website www.animayo.com and with a notary.

MODIFICATIONS

The Promoter reserves the right to make any changes, suspend, or extend this promotion, notifying with sufficient advance notice on the contest website, www.animayo.com.

APPLICABLE LAW AND JURISDICTION

This promotion is governed by the current Spanish legislation. For any disputes arising from the interpretation or application of these terms, both the Promoter and participants expressly submit to the jurisdiction of the courts of Las Palmas de Gran Canaria, without prejudice to any consumer jurisdiction that may legally apply.
